Terms and Conditions:

1. The bidders are requested to submit downloaded tender forms in two cover system.

Cover No-1, Technical bid containing of EMD, details of financial capability and self-attested experience certificate to undertake the Tender,

Cover No-2, Commercial (price) bid separately before 3.30pm to the under sign in person the time stipulated here in below.

2. The bidder shall be a Government register contractor/private contractor.

3. Self-declaration letter shall be uploaded by the tenderer stating that He or she has not been defaulted or blacklisted by any central/ State Govt. or public sector undertaking of India.

4. The bidders should produce valid GST registration certificate, Pan Card if required.

5. The bidder shall furnish the work done certificate for having executed one similar type of civil work not less than 50% amount each work and completed satisfactorily (in Cover No.1)

6. The bidders are requested to submit technical bid & commercial bid separately before the date and time stipulated herein below.

Time Schedule:

1. General Conditions of contract :

- a. The contractor should quote their rates exclusive of GST.
- b. The contractor shall quote item wise rates in the tender and the same shall hold good till works are completed. The rates should include provision for payment of income Tax, Royally or any other such taxes due to the Corporation/Government notified by the Government to time. The rates quoted should be inclusive of all lead and lift for materials etc.
- c. The bidders must and should visit the work spot at his own cost before quoting the rates by ascertaining the local conditions.
- d. If the bidder quotes the amount below the amount put to tender, the bidder shall deposit the difference in cost as additional performance security in the form of Demand draft/ pay order in favor of Alliance Francaise de Bangalore payable at Bangalore. The same will be refunded after the completion of work without interest.
- e. The successful bidders shall not employ any child labour in the work site.
- f. No materials will be supplied except Electricity and water. The bidder has to make his own arrangement for procurement of required materials, to complete the work.
- g. Conditional bid is liable for rejection without assigning any reasons.
- h. The successful bidders shall bind himself to abide by the rules and specification in force and shall execute the necessary agreement on stamp paper within Four days from the date of intimation of acceptance of his bid, failing which, his bid will be

cancelled unconditionally. In addition they would also be responsible for making good the extra expenditure that would be incurred in inviting fresh bids for the work.

i. Quantities given in the notification and schedule are approximate and are liable to vary.

j. the work should not be sub – let.

k. the bidder has to pay compensation to the disabled or deceased workmen under him for any injury or death caused during the execution of works, failing which the necessary amount will be deducted from the bills and paid to the injured or deceased. AFB is not responsible for any kind of accidents or mis happens at site during the execution of work.
